Should any dispute arise with regard to this agreement, at the request of either party it may be decided by arbitration to be conducted in Rutland, Vermont in accordance with the rules of the American Arbitration Association. The decision made and any award rendered by the arbitrator shall be final and may be entered and enforced as a final judgment in a court of competent jurisdiction within the State of Vermont. No matter where signed, this Agreement shall be governed by the laws of the State of Vermont and contains all agreements of the parties.

We understand that this agreement contains an agreement to arbitrate. After signing this document, we understand that we will not be able to bring a lawsuit concerning any dispute that may arise which is covered by the arbitration agreement, unless it involves a question of constitutional or civil rights. Instead, we agree to submit any such dispute to an impartial arbitrator.

4. When a boy comes to camp from a home that is undergoing change (new location, new school, separation, etc.) his experience and adjustment is often affected. Are any of these changes a part of your son's life and if so, how is he adapting?
5. What do you particularly wish your son to gain from his experience at *Night Eagle Wilderness Adventures*?
